1. The Application is granted in its entirety.

2. The Debtor is authorized to retain and employ Clars as its art appraiser, pursuant to section 327(a) of title 11 of the United States Code (the “Bankruptcy Code”), to perform the services described in the Application and in the Proposal attached thereto as Exhibit A.

3. As described in and in accordance with the Application and the Proposal, Clars compensation is hereby fixed pursuant to Federal Rule of Bankruptcy Procedure 6005 and the Debtor is authorized to pay such compensation without further order of the Court, as an expense of administration pursuant to sections 507(a) and 503(b) of the Bankruptcy Code.
